A BILL

To amend title 38, United States Code, to improve homeless
veterans reintegration programs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Reaching Every Home-
5 less Veteran Act of 2021”.

6 **SEC. 2. GRANTS FOR HOMELESS VETERANS REINTEGRA-**
7 **TION PROGRAMS.**

8 (a) GRANTS.—Section 2021 of title 38, United States
9 Code, is amended—

1 (1) by redesignating subsections (b) through (e)
2 as subsections (c) through (f), respectively; and

3 (2) by inserting after subsection (a) the fol-
4 lowing new subsection:

5 “(b) GRANTS.—(1) In awarding grants for purposes
6 of conducting programs described in subsection (a), the
7 Secretary of Labor shall, to the maximum extent prac-
8 ticable, consider applications for fundable grants from en-
9 tities in all States.

10 “(2) In each State in which no entity has been award-
11 ed a grant described in paragraph (1) as of the date of
12 the enactment of the Reaching Every Homeless Veteran
13 Act of 2021, the Secretary of Labor shall, in coordination
14 with the Director of Veterans’ Employment and Training
15 in the State, organize and conduct an outreach and edu-
16 cation program to ensure communities are aware of the
17 programs conducted under this section and the benefits
18 of the programs.”.

19 (b) CONTENTS OF BIENNIAL REPORT TO CON-
20 GRESS.—Subsection (e) of section 2021 of such title, as
21 redesignated by subsection (a)(1), is amended—

22 (1) by inserting “(1)” before “Not less”; and

23 (2) by striking the second sentence and insert-
24 ing the following:

1 “(2) The Secretary of Labor shall include in each re-
2 port submitted under paragraph (1) the following:

3 “(A) An evaluation of services furnished to vet-
4 erans under this section.

5 “(B) An analysis of the information collected
6 under subsection (c).

7 “(C) An identification of—

8 “(i) the total number of applications for
9 grants under this section that the Secretary re-
10 ceived during the fiscal year preceding the date
11 on which the report is submitted; and

12 “(ii) the number of such applications that
13 were denied.

14 “(D) With respect to each State in which no
15 entity was awarded a grant under this section dur-
16 ing the fiscal year preceding the date on which the
17 report is submitted—

18 “(i) an identification of the top five rea-
19 sons why entities that applied for such a grant
20 were not awarded the grant; and

21 “(ii) information regarding the specific cri-
22 teria used to score the applications and an ex-
23 planation of if, how, or why such criteria dif-
24 fered from the previous fiscal year.”.

1 (c) CONFORMING AMENDMENT.—Section 2021A(e)
2 of title 38, United States Code, is amended by striking
3 “section 2021(d)” and inserting “section 2021(e)”.
