**A BILL**

To require a full audit of the Board of Governors of the Federal Reserve System and the Federal reserve banks by the Comptroller General of the United States, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Federal Reserve  
3 Transparency Act of 2013”.

4 **SEC. 2. AUDIT REFORM AND TRANSPARENCY FOR THE**  
5 **BOARD OF GOVERNORS OF THE FEDERAL RE-**  
6 **SERVE SYSTEM.**

7 (a) IN GENERAL.—Notwithstanding section 714 of  
8 title 31, United States Code, or any other provision of law,  
9 an audit of the Board of Governors of the Federal Reserve  
10 System and the Federal reserve banks under subsection  
11 (b) of such section 714 shall be completed within 12  
12 months of the date of enactment of this Act.

13 (b) REPORT.—

14 (1) IN GENERAL.—A report on the audit re-  
15 quired under subsection (a) shall be submitted by  
16 the Comptroller General to the Congress before the  
17 end of the 90-day period beginning on the date on  
18 which such audit is completed and made available to  
19 the Speaker of the House, the majority and minority  
20 leaders of the House of Representatives, the major-  
21 ity and minority leaders of the Senate, the Chairman  
22 and Ranking Member of the committee and each  
23 subcommittee of jurisdiction in the House of Rep-  
24 resentatives and the Senate, and any other Member  
25 of Congress who requests it.

2        nancial institutions regarding the procedures to be  
3        followed in conducting the file reviews;

4            (2) the factors considered by independent con-  
5        sultants when evaluating loan files;

6            (3) the results obtained by the independent con-  
7        sultants pursuant to those reviews;

8            (4) the determinations made by the independent  
9        consultants regarding the nature and extent of fi-  
10       nancial injury sustained by each homeowner as well  
11       as the level and type of remediation offered to each  
12       homeowner; and

13           (5) the specific measures taken by the inde-  
14       pendent consultants to verify, confirm, or rebut the  
15       assertions and representations made by supervised  
16       financial institutions regarding the contents of loan  
17       files and the extent of financial injury to home-  
18       owners.

19        (c) REPORT.—Not later than the end of the 6-month  
20       period beginning on the date of the enactment of this Act,  
21       the Comptroller General shall issue a report to the Con-  
22       gress containing all findings and determinations made in  
23       carrying out the audit required under subsection (a).
