 5 (a) SHORT TITLE.—This section may be cited as the *Ms. Heitkamp,*
 6 “Military Reserve Jobs Act of 2013”. *Mr. Chambliss,*
 7 (b) PREFERENCE ELIGIBILITY FOR MEMBERS OF *and Mr. Moran)*
 8 RESERVE COMPONENTS OF THE ARMED FORCES.—Sec-
 9 tion 2108 of title 5, United States Code, is amended—
 10 (1) in paragraph (3)—

1 (A) in subparagraph (G)(iii), by striking
2 “and” at the end;

3 (B) in subparagraph (H), by adding “and”
4 at the end; and

5 (C) by inserting after subparagraph (H)
6 the following:

7 “(I) a qualified reservist;”;

8 (2) in paragraph (4), by striking “and” at the
9 end;

10 (3) in paragraph (5), by striking the period at
11 the end and inserting a semicolon; and

12 (4) by adding at the end the following:

13 “(6) ‘qualified reservist’ means an individual
14 who is a member of a reserve component of the
15 Armed Forces on the date of the applicable deter-
16 mination—

17 “(A) who—

18 “(i) has completed at least 4 years of
19 service in a reserve component of the
20 Armed Forces; and

21 “(ii) in each year of service in a re-
22 serve component of the Armed Forces, was
23 credited with at least 50 points under sec-
24 tion 12732 of title 10; or

25 “(B) who—

1 “(i) has completed at least 10 years of
2 service in a reserve component of the
3 Armed Forces; and

4 “(ii) in each year of service in a re-
5 serve component of the Armed Forces, was
6 credited with at least 50 points under sec-
7 tion 12732 of title 10; and

8 “(7) ‘reserve component of the Armed Forces’
9 means a reserve component specified in section
10 101(27) of title 38.”.

11 (c) TIERED HIRING PREFERENCE FOR MEMBERS OF
12 RESERVE COMPONENTS OF THE ARMED FORCES.—Sec-
13 tion 3309 of title 5, United States Code, is amended—

14 (1) in paragraph (1), by striking “and” at the
15 end; and

16 (2) in paragraph (2), by striking the period at
17 the end and inserting a semicolon; and

18 (3) by adding at the end the following:

19 “(3) a preference eligible described in section
20 2108(6)(B) - 4 points; and

21 “(4) a preference eligible described in section
22 2108(6)(A) - 3 points.”.
